Quick Guide for Massively Building the Number of Petition Signers for the ERA

WHY SIGN4ERA.ORG?

The Equal Rights Amendment (ERA) has already been passed by Congress and ratified by 3/4th of the states. **The only step needed to enshrine the ERA as the 28th Amendment to the U.S. Constitution is for Congress to now vote to place it in the Constitution.**

The purpose of Sign4ERA is to build massive nationwide pressure on Members of Congress, candidates for Congress and the presidency and, in fact, elected officials at all levels of government to cease treating women as second-class citizens by putting equality in the U.S. Constitution.



The Dobbs decision on abortion, overturning *Roe v. Wade*, by a radical rightwing Supreme Court with its predisposition for turning back the clock, has created real dangers not only to reproductive health and contraception, but also to gains made in marriage and LGBTQ rights, education, sports programs, sexual violence, equal pay and employment opportunities, and a wide range of additional progress feminists have fought for and won over the past 50 years.

Today, with the rise of vehement, mean-spirited misogynists and determined right-wing extremism — especially in state legislatures and the U.S. Congress — more than ever we need the permanent protection of the Equal Rights Amendment.

That's why a team of students, leaders of scores of feminists, human and civil rights activists, and committed citizens have created **Sign4ERA**, a nonprofit, nonpartisan organization with the sole purpose of enlisting millions of Americans to sign a petition demanding that the ERA now be placed in the Constitution.

This petition is part of a massive nationwide effort that crosses generations and includes racial and ethnic groups and those fighting for sexual and reproductive health, rights, and justice with voters in their teens and voters who have been in this fight for more than 50 years.

Young people, especially young women, overwhelmingly support the ERA. They don't want to be the first generation with fewer rights, and older voters demand that Congress finally recognize their rights.

The older generation wants the long battle for equality won at last. Enough is enough. Too many voters have been cheated long enough. The overwhelming majority of Americans want the ERA in our Constitution.

HOW SIGN4ERA.ORG WORKS

The sole purpose of **Sign4ERA.org** is to collect petition signers in support of the ERA, and to then keep each signer informed on the progress of getting the ERA into the Constitution.

We'll let each petition signer regularly know where progress on the ERA stands, share which politicians and candidates are for it and who's opposed, and suggest action steps individuals can take to bring us closer to victory and full equality.

The names of petition signers will NOT be used for fundraising by other organizations and will not be rented or shared.

Sign4ERA.org is a 501(c)(3) nonprofit chaired by long-time ERA advocate former Congresswoman Carolyn Maloney (D-NY) and managed by a volunteer team of students and long-time ERA activists.

We know from polling that 80 percent or more of Americans support the ERA, and through the petition drive, we want to make this support come alive.

WHY DO WE NEED AN EQUAL RIGHTS AMENDMENT?

IN BRIEF

Politicians change. Partisan majorities in legislature change. Courts change. Consequently, today's legislation or court decisions in support of equal rights can too quickly become tomorrow's denial of rights.

Nothing compares to the permanence of a U.S. Constitutional Amendment and the strongest of legal protections it offers.

SPECIFIC DETAILS ON WHY THE ERA IS URGENTLY NEEDED — NOW!

The answer is both technical and practical.

On the technical side, the ERA is needed now more than ever. Putting the Equal Rights Amendment into the Constitution would mean equal protection under the law from discrimination for all people, regardless of sex. Because the Constitution does not specifically ban gender discrimination or state that equality of rights under the law cannot be denied or abridged on account of sex, as of today, women are not granted equal protection in the Constitution.

As the late Justice Antonin Scalia stated in 2011, the 14th Amendment does not protect against sex discrimination. "The only issue is whether it prohibits [sex discrimination]. It doesn't. Nobody ever thought that that's what it meant."

HOWEVER ... *with* the ERA, in court cases, sex discrimination will be considered a "suspect classification" requiring the highest level of "strict

scrutiny" — the highest judicial standard for deciding cases and a classification not currently applied to sex discrimination.

For practical reasons, with the rise of right-wing extremism, the ERA is needed as a legal tool to prevent reversals and rollbacks of the hard-fought laws that have helped women and girls, including Title IX, the Violence Against Women Act, the Equal Pay Act and other laws passed over the last decades — and to restore rights that have already been lost, including abortion and protection from sexual violence.

...ON ABORTION AND REPRODUCTIVE HEALTH AND RIGHTS:

• For example, in the *Dobbs* opinion, the Supreme Court dismissed the idea that denying access to abortion violates women's constitutional equality rights by stating: "a state's regulation of abortion is not a sexbased classification."

[In a 1974 case, the Supreme Court ruled that a policy excluding pregnancy from a disability insurance program is not sex discrimination in violation of the Constitution's equal protection clause because it does not discriminate between men and women, but between "pregnant and non-pregnant persons." This interpretation of the equal protection clause has never been overruled. In fact, the Court has never interpreted the equal protection clause to provide full equality for women.]

- Several states have ERAs in their constitutions that have been used to expand abortion rights, including by making state funding available for abortions. HOWEVER, these are now exceptions. Most states do not offer such protections. ONLY an ERA in the U.S. Constitution can guarantee these rights nationwide.
- Since the Dobbs decision, 14 Republican-dominated states promptly banned abortion. Alabama, Arkansas, Kentucky, Louisiana, Missouri, Oklahoma, South Dakota, Tennessee and Texas banned abortion with no exceptions for rape or incest.

- Currently, lawsuits are being brought using state ERAs as one tool to reverse the impact of the *Dobbs* decision, and Congress has introduced legislation to restore abortion rights across the country. But legislation, whether state or federal, can be easily changed when legislatures change. Only a U.S. Constitutional Amendment offers the degree of permanence required to protect equality for all genders.
- In addition to abortion, our health care system is riddled with discriminatory practices based on sex related to disease research and access to diagnoses, treatments, contraceptives, and other reproductive services.
- The *Dobbs* decision has the potential for a number of unintended consequences related to fertility treatment, medical privacy rights, reproductive research, and the education of doctors, nurses and other medical practitioners.

...ON DOMESTIC VIOLENCE & SEXUAL ASSAULT

For years, most of us were under the belief that victims of sexual assault and violence could hold their abusers accountable with lawsuits filed in federal courts under the Violence Against Women Act.

Wrong!

The frightening fact is that the right-wing U.S. Supreme Court — even before overturning *Roe v. Wade* — ruled that a university rape victim could not sue her rapist in federal court. Why? Because the Equal Protection clause of the 14th Amendment does *NOT* cover women.

In short, while most people believe the Violence Against Women Act, which was passed 27 years ago, provides civil remedies for victims of sexual assault ... they're wrong.

The shocking fact is that no federal law allows women — even the dozens who were raped and assaulted by the likes of Harvey Weinstein

— **to sue.** This despite the fact Weinstein was sentenced to 23 years in prison for rape and sexual assault under state laws.

Worse still, the right-wing Court also held that the Constitution bars Congress from ever even passing such a law.

When Congress recognizes the ERA, the right-wing Supreme Court can no longer claim that because the words "sex" and "equality" aren't in the Constitution, their hands are tied. The ERA takes care of that.

Most importantly, it will spark Congress to enact new, tougher laws on gender violence.

...ON ECONOMIC RIGHTS

Women are being paid, on average, about 75 cents for every dollar paid to men. For African American women, the pay drops to 63 cents, and for Hispanic women, it drops to 59 cents.

This is only a snapshot of **one-year averages**. However, **over a lifetime, women will take home between \$500,000 and several million dollars less than men** due to pay discrimination and in Social Security, pensions, bonus pay and other retirement programs.

The ERA could pave the way for bringing new pay equity cases that go beyond equal pay for equal work — to equal pay for work of comparable value that could end the persistent gender pay gap.

YOUNG WOMEN ESPECIALLY NEED THE ERA!

The ERA is an important amendment to the United States Constitution that would ensure equal rights for all citizens regardless of gender. Young women especially are supporting and pushing for its passage, as it could have a major impact on this younger generation and those of future generations. Here are three reasons why young women should fight for the ERA: First, without the Equal Rights Amendment in the Constitution, there is no guarantee that women will be treated equally under the law.

Even though some states have passed laws guaranteeing equal rights between genders, these laws can easily change or even disappear depending on who holds political power at any given time. The ERA would provide a permanent legal foundation to protect against discrimination based on gender and help ensure that all individuals receive fair treatment from employers and other institutions regardless of their sex or gender identity.

Second, passing the ERA could open new opportunities in education and employment fields traditionally dominated by men, such as science, technology, engineering and math (STEM) careers, which tend to pay higher wages than many other professions available today.

Women currently face obstacles when trying to break into these industries due to long-standing cultural biases; however, with greater legal protection they will be more empowered to take advantage of better job prospects in STEM fields. This could lead to increased economic security and greater representation of female leadership across different sectors of our economy. A diverse workforce is better for the economy and for everyone.

Finally, the Equal Rights Amendment in the Constitution sends powerful messages about the principles and values our society holds dear and demonstrates a commitment to fairness, inclusion, equality and justice. These principles are essential building blocks of our democracy that must be upheld if we want continue progress toward creating a just and equitable world where everyone can thrive.

Together, let's make sure the next generation has the same chance to reach their full potential and realize their dreams!

LET'S MAKE THIS THE BIGGEST PETITION CAMPAIGN EVER!

The Equal Rights Amendment (ERA) needs and deserves the biggest petition drive ever. Our goal is to have as many folks of every age and gender ... as many organizations ... and as many elected officials as humanly possible add their names to the Sign4ERA.org Petition.

There's no mystery to achieving this goal. This Toolkit contains sample messages and graphics you are free to use. Your tasks, as an ERA advocate, are clear and simple:

Step #1: Set an achievable target for the number of signatures you want to secure and a deadline for getting them. Perhaps you want to contact five friends, or maybe you want to send an email to your entire email list. It's entirely up to you.

Step #2: Prepare your message (for suggestions, see section of this Toolkit for sample messages and graphics) and ask the folks you're contacting to sign the online petition [**SIGN4ERA.org**] by a certain date.

If you'd like to know which of your contacts responded, we can tell you that. All you need to do is provide a link that has some additional details in it as described below.

Step #3. If you want to take this step of tracking your responses, see the Section of this Toolkit on tagging and tracking. *Once you've added your special tracking URL*, please let us know what it is by contacting <u>Team@Sign4ERA.org</u> and we'll keep you updated.

That's it. JUST THESE TWO OR THREE SIMPLE STEPS FOR THE ERA AND A MASSIVE VICTORY FOR EQUALITY.

TIPS FOR GREATER SUCCESS

Because you've created a meaningful message, always ask participants to "share with friends." The top sharing channels will be email, Facebook, Twitter, Instagram and TikTok. When you prepare your message, your confirmation page should give signers the ability to share with friends.

For greatest success, go to your friends and supporters first. If you use Facebook, they can help you find audiences similar to yours (lookalikes) or friends of your fans (likes).

ORGANIZATIONS HAVE A SPECIAL ROLE TO PLAY!

Urge every organization you which you belong to spread the word and conduct a Sign4ERA.org campaign in the organization's name.

Scores of women's rights, civil rights, human rights, LGBTQ+ rights, and professional and social organizations are urging their members to Sign4ERA.

Make sure you urge every organization where you are a member to do the same. AND ... send them a copy of this SIGN4ERA.ORG Toolkit so they can act immediately. If people have questions you can't answer about this campaign, just ask them to contact Team@Sign4ERA.org and we'll answer their questions.

The Sample Messages and Graphics section of this Toolkit contain examples that organizations can easily adapt and customize for their use. It's also important to stress that the names and contact information of an organization's members who sign the petition will NOT be shared, rented or used for any purpose other than growing the size of the petition list.

EVEN BETTER ... the organization will be given the list of every member who signs the petition *provided* the organization uses a special tracking code and lets Team@Sign4ERA.org know what it is. [See next section on Tracking]

TRACKING YOUR EFFORTS

As noted earlier, we're able to let you or any organization you invite into this campaign know who among their friends, members or mailing lists responded to the Sign4ERA Petition.

How to add a special tracking code to the SIGN4ERA Petition

In Word, type in the petition url: www.sign4era.org

This will automatically create a hyperlink to the petition website. Return to the Word document. Highlight the hyperlink to the website like this:

www.sign4era.org

Then right click and go to Edit Hyperlink...



Then on the Text to Display (see below), keep www.sign4era.org.

In the *Address*, keep the URL **but add a backslash** after .org and then add? (a question mark) followed by the tracking letters (for this sample, it is /?mycode) — replace the "mycode" sample with your or your organization's initials or other text of your choice.

Thus, what appears is http://www.sign4era.org

but with the code, it would be www.sign4era.org/?mycode

You can add any letter after a ? — as in /?VaNOW for Virginia NOW or /?LWVNY for League of Women Voters NY.

Once you've sent your message(s) with the tracking code, let us know the code by emailing us at Team@Sign4ERA.org and we will then be able to send along a list of respondents upon request. If you have questions about tracking codes, just email Team@Sign4ERA.org and we'll give you all the help you need.

TO CLOSE FRIENDS OR FAMILY WHO SUPPORT THE ERA

I am writing to you as a (sister/fellow) supporter of women's rights and equality.

I am asking you to <u>sign a petition</u> to Congress to recognize the already-ratified Equal Rights Amendment (ERA) and pass a resolution to put it into the U.S. Constitution.

The ERA is a simple but powerful amendment that would guarantee equal rights for all citizens regardless of sex. It would protect women from discrimination in employment, education, health care, and more.

The ERA was first introduced in Congress in 1923 and finally passed in 1972. It was then sent to the states for ratification but had an arbitrary deadline of 1982. By then, 35 states had ratified it, three short of the required three-fifths. Activists in unratified states continued to fight for equality and in 2020, Virginia ratified the ERA to provide the needed 38th state.

In April, the U.S. Senate voted on a resolution to remove any time limits and recognize the ERA as the 28th Amendment to the Constitution. A majority of Senators voted for the ERA, but it failed to get the 60 votes needed to override a filibuster by opponents.

This is unacceptable and unjust. The ERA is not dead, it's just on pause. It is still valid and vital for ending discrimination based on sex.

Fortunately, a new pro-ERA Resolution is now before Congress that will remove this arbitrary time limit. Passage by a simple majority in the House and Senate will remove any doubt about ratification and formally enshrine the ERA as the 28th Amendment.

Our job is to help pass this Resolution and get all our Representatives and Senators on record as being "For" or "Against" the ERA. For or against giving women the right and the power to hold their abusers accountable.

After you sign, send this petition to all your friends. Our goal is to continue growing the number of signers nationwide to mirror the support in the polls. Congress must have no doubt of the overwhelming public support for the ERA.

You and I have been fighting this fight for a long time. Now is the time for each of us to do our part to **seize the moment**. **Together we can make history**.






POSTERS, PASS-ALONGS or SOCIAL MEDIA BANNERS
